### Pritchard appointed Secretary General at ACE

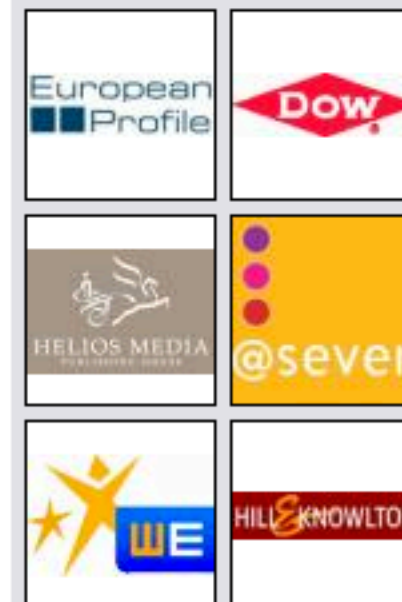
