## ACE CORE ISSUES

### Modernisation of the Professional Qualifications Directive



Following the entry into force of the [2013/55/EU Directive](#) on 17 January 2014, the EU Commission organised a conference on 12 February to discuss the changes introduced by the new Professional Qualifications Directive (PQD). In his opening speech, P. Delsaux, DG MARKT's Deputy Director-General,

emphasised the main innovations of the new PQD: the introduction of a European Professional Card; the update of the minimal training requirements (for the architects, either five years of university level training ("5+0") or not less than four years of study supplemented by a supervised professional traineeship of a minimum of two years ("4+2")); the introduction of the concept of partial access; as well as the promotion and support of CPD. In his closing address, Commissioner M. Barnier stressed that the objective of the on-going mutual evaluation exercise to assess barriers restricting access to regulated professions is not to deregulate but to find the best balance between professional mobility and consumer safety.

### The EU Parliament and Council adopt the new Public Procurement legislative package



On 11 February 2014, the EU's Council of Ministers adopted the legislative package modernising the Public Procurement Directives, following approval by the Parliament a month earlier. The EU legislator recognises in the modernised Directive the most important problems in procuring architects' services, namely the lack of real competition resulting from the mis-use of selection criteria and the focus of awarding criteria on price rather than quality. The ACE is currently working on recommendations for the transposition of the new provisions into national law. This guideline document will contain recommendations on the procurement procedure and on the application of European provisions for design contests and will evaluate the application of public procurement rules in the Member States, highlighting examples of good practice and malpractice. These recommendations will aim to help open up the market for young professionals and small offices, and to shift the emphasis from a one-dimensional, price perspective to one that includes other factors such as sustainability, the environment, quality and life-cycle costs. The legislation will enter into force on 17 April 2014. Member States will then have 24 months to implement the provisions into national law. **An EU tool to help firms compete for public contracts in third countries**



On 15 January 2014, the EU Parliament approved plans for a tool to allow EU countries to prevent non-EU firms from bidding for public procurement contracts, unless their home countries reciprocate by allowing EU firms to do likewise. The proposed tool, which could be used only with the EU Commission's approval, should strengthen the EU's hand in trade talks with third countries. The tool could be used only for big public contracts (worth €5 million or more) and those in which goods or services originating outside the EU make up more than 50% of the total value of the goods or services involved. It will apply to those countries which do not have an international agreement covering public procurement with the EU but exclude least-developed countries. According to the Commission, 85% of EU public procurement markets are already potentially open to international bidders, compared to only 32% of public contracts in the USA and 28% in Japan. The [approved text](#) will now serve as a basis to negotiate the regulation with the Council.

**2030 framework on climate and energy policies**


On 22 January 2014, the EU Commission published a [communication on a policy framework for climate and energy policies in the period from 2020 to 2030](#). In this document, the Commission proposes a new reduction target for domestic green house gas emissions of 40% compared to 1990, accompanied by a coherent headline target at European level for renewable energy of at least 27%. However the Commission postponed the decision on whether or not to set 2030 energy savings targets to the review of the

Energy Efficiency Directive that is announced for July. The Architects' Council of Europe fully supports the [position of the Coalition for Energy Savings](#), of which it is a member: only a 40% binding energy savings target for 2030 can deliver EU objectives for competitiveness, energy and climate. EU Ministers will examine the EU's 2030 climate and energy framework during the next European Council meeting on 20-21 March and then adopt conclusions in June.

**Production in construction up by 1.3% in EU28**



In January 2014 compared with December 2013, seasonally adjusted production in the construction sector grew by 1.5% in the euro area and by 1.3% in the EU28, according to first estimates from Eurostat, the statistical office of the EU. In January 2014 compared with January 2013, production in construction increased by 8.8% in the euro area and by 7.3% in the EU28. The highest increases in output in construction were observed in Slovenia (+22.4%), Spain (+5.8%) and Germany (+4.4%), and the largest decreases in Romania (-4.3%), Slovakia (-3.9%) and France (-2.2%). ## 12<sup>th</sup> ACE Economic Trends Survey

### Encouraging signs of recovery of the architectural market

The twelfth ACE economic trends survey, carried out in December 2013 and January 2014, shows encouraging trends in the profession and the architectural market. Over the last year, the number of respondents considering that the current situation for architectural practice is good or very good has more than doubled, increasing from 9.1% in January 2013 to 21.9% in January 2014. Nevertheless, despite a downward trend, more than half of respondents still consider that the current situation is bad or very bad.

Figures show that the situation differs greatly from one country to another. Whereas the market in Southern and Central Europe seems to remain at standstill, the situation in Northern Europe, headed by Norway, Sweden and Finland, remains very good.

The increased level of optimism is probably fed by a slight increase in short-term workload forecasts. While respondents report upward trends in workloads in all the segments of the market, the public and private housing sector sees the most significant evolution.

These positive trends are reflected in staff changes and short-term staffing forecasts. The number of offices with growing staff numbers since 2008 has increased and the number of those expecting an increase in staff numbers for the next three months has steadily grown since 2010 (from 10.1% to 15.2% in 2014).

The survey confirms, therefore, that the situation is stabilising and that the tentative signs observed in the previous surveys have turned into encouraging trends, suggesting a gradual recovery of the market.

Following an engineer's appeal against exclusion from a public work, the Italian High Court reiterated in January 2014 that only architects can intervene on monuments and listed buildings.
