Luciano Lazzari, President of the Architects' Council of Europe

Mr Lazzari has been President of the Architects Council of Europe since 2014, and was formerly a Board Member and Vice-President for Communications. He is also a practising architect based in Trieste, Italy.



Irmfried Schwimann, Deputy Director-General DG GROW

Ms Irmfried Schwimann has been in charge of the DG GROW Directorates covering the Single Market and the Entrepreneurship programme, COSME since 16 March 2016.

An Austrian national, Ms Schwimann holds a Diploma in Political Science and a Doctorate in Law. She has been working in the European Commission since 1999. She first became Head of Unit in 2003 and was promoted to the position of Director in DG COMP, where she also set up, the "Financial Crisis Task Force" which she has led since 2009.



Ian Pritchard, Secretary General of the Architects' Council of Europe

Mr Pritchard has been Secretary General of the Architects Council of Europe in Brussels since 2012. Before that, he held various Directorships at the Royal Institute of British Architects in London, focusing on Policy, Public Affairs, Regulation & International Relations. He also worked at the International Union of Architects (UIA) in Paris.



Martin Frohn, Head of Unit Professional Qualifications & Skills at DG GROW

Mr Frohn is in charge of the Professional Qualifications & Skills Unit at DG GROW. He has worked at the European Commission on the free movement of services since 2000. He was formerly Deputy Head of Unit in the "Corporate Governance, Social Responsibility" unit and until 2014, he led the "Free movement of Professionals" unit in DG Internal

Market and Services. Mr Frohn studied Law in Germany and in the United States.
