Welcome to the September issue of the *ACE Info*

Introduction by Selma Harrington, ACE President



The summer has breezed by and we warm up to autumn activities, mindful of the broader political and economic context in Europe.

The ACE' focus has remained on the communication around the EU Commission's Green paper and public consultation on the modernization of the Professional Qualifications Directive, with the looming deadline of 20th September for any further submission. We seek support from our Member organizations directly and through their political representatives to uphold the ACE '5+2' position - five years of university education and two years of practical professional experience leading to registration.

The ACE position was recently presented to the educators from some 120 schools of architecture in Europe, in Chania, Greece at the recent meeting of network of Heads of Schools of Architecture (ENHSA). Having acknowledged the shared views, the ACE is now asking for the coordinated and direct action by the schools at national levels.

The ACE Executive Board has been extremely busy during the summer and we can now look forward to announcing the appointment of the new Secretary General at the General Assembly this November. In the meantime, we can be grateful to the EB members and our Staff who continue to work closely together so that the core work continues uninterrupted despite fewer resources. We hope to continue in good spirit with the strengthened team in the Secretariat in the near future.

I look forward to welcoming you in Brussels at the General Coordination meeting this 15th September and at the General Assembly on the 25th November.

EU Green Paper on Modernising the Professional Qualifications Directive



Following the EU Public Consultation on the evaluation of the Professional Qualifications Directive (PQD), the EU Commission launched a Green Paper on the modernisation of the Directive at the end of June 2011. Being an important issue for the architectural profession, the ACE Work Group PQD has been preparing a legislative proposal for the modernisation of the Directive during the summer, inviting all member organisations, ACE correspondents and interested parties to comment the prepared draft. The ACE response has recently been sent to the Commission and is now available on the ACE website. Following the Green

Paper, the EU Commission will organise a high level conference on the 7th November 2011 and a legislative proposal is foreseen for December 2011.

As it was stated before, the PQD Directive is crucial for architects as it sets the conditions by which migrating professionals in the EU have their qualifications recognised in the country to which they migrate and, for architects, this process is automatic. Maintaining the automatic recognition of qualifications for architects and revising the minimum training requirements are two key objectives of the ACE in its work on this important piece of legislation. New Polish EU Presidency



Since the 1st of July Poland has taken over the six months rotating EU Presidency. Taking into account the economic crisis and its impact on enterprises, the Polish Presidency, together with Denmark and Cyprus, which are part of the trio EU Presidency, will accelerate changes in the Single Market to enhance economic growth and build a competitive Europe. To do so, the Presidency will promote the full implementation of the Services Directive and allow enterprises, especially small and medium ones, to reap more benefits from the Single Market. The Presidency will also support the next Framework for EU Research and Innovation and will pay a special attention to its accessibility for SMEs. In the series of event that will take place during the Presidency, an important conference on Sustainable Development will address the green economy and the global institutional framework for sustainable development. Horizon 2020 – New Framework Programme for Research and Innovation



In June 2011, the EU Commissioner for Research and Innovation, Mrs Geoghegan-Quinn, announced the new name of the future EU-funding programme for research and innovation (FP8): *Horizon 2020*. This programme will be introduced post-2013 and will maximise the contribution of EU funded research and innovation to sustainable growth and jobs. EU Commission Takes Measures to Boost e-Procurement



In July, the EU Commission launched different actions to boost the implementation of e-procurement in the EU. According to the EU Commissioner Mr Barnier, the use of e-procurement by governments and other public sector organisations when buying supplies and services or tendering public works will not simply changed paper-based procurement systems to electronic communications. It has the potential to streamline and accelerate public purchasing, benefiting purchasers and suppliers, as well as the European taxpayer. Three measures have been taken. Firstly, the Commission will create a new and informal expert group on e-tendering. Secondly, it is starting to monitor the use of e-procurement across Member States in order to promote best practises. Thirdly, it is publishing the responses to the e-procurement Green Paper on expanding the use of e-procurement. Open House – FP7 Project



The [OPEN HOUSE](#) project team is working to create an open-source, web-based sustainability assessment tool for all buildings. The first [deliverables](#) of the project are now published. Among those, an assessment of existing methodologies and standards for the sustainability of buildings, a Best Practice Guide on Green Public Procurement, and the Open House baseline model and assessment methodology. The developed Open House baseline model and assessment methodology will be evaluated and refined in the months to come through the execution of particular Case Studies across Europe. The ACE would like to thank all the architects who have answered to the call and nominated buildings for this purpose. A new call for the execution of the selected Case Studies by means of the developed methodology was recently launched. The deadline for the submission of Tenders is the 7th of October 2011. The deadline for the nomination of new or in design/ construction phase office buildings to be used as Case Studies has been extended to this date. Shelter – An Intelligent Energy Europe Project



The [SHELTER](#) project is bringing together architects, construction enterprises and social housing organisations, in energy renovation projects. The project is linked to [POWERHOUSE EUROPE](#) and has a special community set in [BUILDUP](#). The goal of the project is to implement models of cooperation inspired by integrated design for the energy renovation of social housing. This will ensure long-term gains in costs and time for professionals and social housing organisations in the energy renovation of their building stock. The first report submitted is presenting the existing models of coordination in energy renovation works of six social housing associations in 5 European counties (BE,

BG, FR, IT, UK). The second delivered report identifies weaknesses in the existing schemes and proposes possible alternative models of coordination among professionals that can be applied. Both deliverables are now public documents and can be accessed from the [SHELTER](#) website as well as an embedded page in [POWERHOUSE](#).

TrainRebuild – An Intelligent Energy Europe Project



The [TRAINREBUILD](#) project aims to encourage retrofitting in a wide range of residential buildings, spanning from individual to multi-family houses and from private to social housing. There are two core groups targeted by the TRAINREBUILD project: Property owners associations and Officials from local authorities that are responsible for the retrofit of buildings in some Covenant of Mayors (CoM) cities. At the current phase of the project, training packages and toolkits are prepared for both targeted groups. A draft Toolkit for [Local Authorities](#) is already available for download at the projects' website. The training package for building professionals is due to be completed this autumn, after its already developed draft version is adapted to national, regional and local specifications. Moreover, a BUILDUP Virtual Community on « [Training the Building Chain for Refurbishing](#) » has been set up. This Community is an interactive tool focussed on the topics and target groups of the TRAINREBUILD project. You are invited to join this Community and share your knowledge and expertise. Caribbean Artists Benefiting from EU-CARIFORUM Economic Partnership Agreement

In October 2008 the EU and the 15 Cariforum countries signed an Economic Partnership Agreement (EPA). At that time it was the first EU trade agreement with third countries that specifically included the cultural sector. Almost three years later, in July 2011, a study carried out by KEA European Affairs for the European Centre for Development Policy Management (ECDPM) shows how Caribbean artists are benefiting from EU-Cariforum EPA. The ECPDM study indicates how the cultural provisions of the EPA were implemented in eight EU Member States. It also examines the activities and funding programmes developed by the EU Commission and the EU Member States. The conclusion of the study is that EU Member States and the Cariforum countries are still in very early stages of implementing the cultural provisions of the EPA. Consequently KEA European Affairs prepared a set of 29 recommendations for actions in order to boost cultural cooperation and trade. For full information on the study, go to:

Winners of the International Competition for Urban General Plan of Rio 2016 Olympic Park

On the 19th of August, the Municipal Olympic Company, in partnership with the Brazil's Architects Institute (IAB), unveiled the winning project of the International Competition for the Rio 2016 Olympic Park Urban Masterplan. The competition winner is AECOM, a global service provider, which is already responsible for the London 2012 Olympic Park Masterplan. According to IAB, the winning project distinguishes itself with "the operational concept, the separate access to athletes and the spectators, the logistics of the transportation system, the execution feasibility and an exclusive way to parking. In terms of legacy that the project will leave to the city, the highlights referred to environmental preservation, the maintenance feasibility and the preservation of the lagoon." The competition brought together 60 entries from firms in 18 countries and the jury consisted of representatives from the Rio City Hall, the International Union of Architects, the Brazil's Architects Institute, the Rio 2016 Organising Committee for the Olympic and Paralympic Games and the Federal Government. After analysing the three-year transposition phase of the Services Directive, Eurochambres organised a further edition of the survey, focusing on the Points of Single Contact (PSCs). Conducted in late 2010, the survey provides a key indicator whether the main operational element of the directive has, from a business perspective, been delivered in a timely, complete and correct manner.
