### INTRODUCTION

This year's *Mostra* promises to reflect on the very essence of the profession under direction of Director David Chipperfield: ***"The role of the architect is at best one of critical compliance. Architects can only operate through the mechanisms that commission them and which regulate their efforts. Our ideas are dependent on and validated by the reaction of society. This relationship is not only practical but concerns the very meaning of our work. In the increasingly complex confrontation between the commercial motivations of development and our persistent desire for a humane environment there seems to be little dialogue. If architecture is to be more than the privileged, exceptional moments of our built world, we must find a more engaged collaboration of talents and resources. Common Ground invites us to consider how these shared perceptions, concerns and expectations may be better directed."***

These words echo many discussions with colleagues from the ACE network and wider. They convey a profound message and invite us to take action. They also demonstrate a momentum gathering prominence not only among architects, but also in other segments of society.

Among many other activities, which this Info highlights, the ACE General Assembly on 30 November is planning to enable an engaged dialogue and explore how our profession can make contribution in the context of the 'Construction 2020' document recently launched by the European Commission. Under the working title 'Architect 2020', I invite you to participate in the program contributing to topics like *Forecasting and Responding to Change, Regulation versus Trust, Value versus Volume and New Realities and New Opportunities*.

### **Construction 2020: ACE welcomes new EU Strategy to promote Construction Sector**



ACE warmly welcomes the new Commission's Action Plan to promote the construction sector as a driving force for the creation of jobs and sustainable growth in Europe. On 31 July 2012, the Commissioner for Industry and Entrepreneurship, Antonio Tajani, presented the five key objectives of this plan, which are: (1) stimulating favourable investment conditions, (2) improving the human-capital basis of the construction sector, (3) improving resource efficiency, environmental performance and business opportunities, (4) strengthening the internal market for

construction and (5) fostering the global competitive position of European construction enterprises. ACE is prepared to join the High Level Group or Forum that will oversee the implementation of the strategy and make recommendations on any necessary adjustments. To offer its support, exchange views and attend a reflexion on this new initiative, ACE will invite Mr. Tajani during its second General Assembly at the end of November 2012. ### **Professional Qualifications Directive: ACE Feedback on Rapporteur's Report**



On 16 July 2012, MEP Bernadette Vergnaud published her draft report on the Professional Qualifications Directive. In the main ACE is satisfied with much of the proposed draft as it reflects, in a number of areas, the position ACE submitted to the rapporteur on 22 June. Concerning the minimum training duration for architects, the Rapporteur is currently retaining the proposal to have at least six years of training but she supported ACE amendment to include a minimum of four or five years full-time studies "or equivalent ECTS credits". For practical training, Ms. Vergnaud accepted ACE's proposal that it should be supervised by an architect or a person or a body approved by the competent authority, which carried out an appropriate verification of his/her ability to provide practical training. However, regarding the principle of partial access, Ms. Vergnaud did not accept ACE's proposed deletion of this. Rather, she proposed that "for reasons of overriding general interest, as in the case of any professions having responsibilities with regard to public health, safety or health monitoring, Member States must be able to exclude the professions concerned from the partial access provisions". The amendment is potentially more inclusive than the former one from the health professions and could therefore be constructed to include architects. On 18 September 2012, the draft report will be discussed in the Committee for Internal Market and Consumer Protection (IMCO). Deadline for tabling amendments is 15 October 2012.

### **Public Procurement Directive: ACE calls on the EU to amend its legislative proposal**

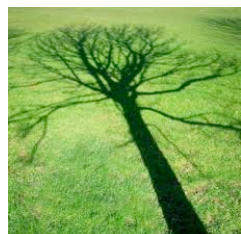


ACE recently submitted draft amendments in response to the proposed modernisation of the Public Procurement Directive. While welcoming the Commission's decision to modernise the Directive, ensure efficient use of public funds, improve the business environment and generally increase SME access to the market, ACE reiterated the fact that current access to public contracts for architects is virtually non-existent. An ACE study of professional practice reveals that the application of turnover requirements

would exclude 90% of architectural firms from public procurement contracts. As a consequence, the ACE submission seeks to facilitate participation of architectural firms (mostly SMEs) in public procurement, promote selection procedures and award criteria based on quality and ensure that the specific nature of intellectual services is taken into account. If adopted on 10 October 2012, the

Directive will have to be implemented by Member States by 30 June 2014 latest. ### Energy Efficiency Directive: Deal omits expected national targets



Late on 13 June 2012, all three European legislative bodies reached a last-minute agreement on the Energy Efficiency Directive. Shepherded by the Danish Presidency of the Council of Ministers, negotiations between MEPs and Member States were tense and new additional exemptions and measures had to be added late in order to save the deal. Unfortunately, given the manner in which it was agreed, many observers fear that Europe will not meet its pledge to reduce energy consumption by 20% by 2020. In fact, most of the European Commission's ambitious proposals for immediate binding national targets have been erased. In particular, the Directive has abandoned the proposal on public building renovation requirements (article 4), which called for 3% renovation of the total floor area (over 250m<sup>2</sup>) of buildings owned by public bodies each year. Instead the new Directive would require Member States to renovate 3% of the total floor area of heated and/or cooled buildings owned and occupied by their central government and would only apply to buildings with a total useable floor area of more than 500m<sup>2</sup>. As a result the provision will only affect a small percentage of all public buildings (10%), which is considerably below initial expectations. Nevertheless, to offset the watering down of the renovation of public buildings proposal, the European Parliament introduced a promising measure in article 3a of the Directive, requesting EU Member States to draw up a roadmap to make the entire building sector more energy efficient by 2050. This long-term strategy for the renovation of the entire building stock should be finalised by April 2014 and give new hope to the construction sector.

On 12 July 2012, Parliament's ITRE Committee adopted unanimously the EED deal. The first reading in Parliament is scheduled for adoption during the September plenary session. ### Further Steps on Energy Roadmap 2050



On 12 July 2012, the rapporteur Niki Tzavela presented his draft report on the Energy Roadmap 2050 to the MEPs of the Industry, Research and Energy Committee (ITRE). Among MEPs participating to the debate, shadow rapporteur Van Brempt called for energy efficiency targets and MEP Fiona Hall proposed an objective of 45% of renewable energy sources by 2030. Before the final report, which is due to be adopted in committee at the end of 2012 (18 December) and in plenary in early 2013, the European Parliament will organise a public hearing on 17 September 2012. As a reminder the European Commission adopted, at the end of last year, the Energy Roadmap 2050 to explore challenges posed by delivering the EU's decarbonisation objectives while at the same time ensuring security of energy supply and competitiveness. ## ACE MATTERS

### International Presidents' Forum at AIA 2012 National Convention



On Friday 18 May 2012, ACE President, Selma Harrington, participated to the International Presidents' Forum at the AIA 2012 National Convention. On this occasion, the invited Presidents of a dozen national, regional, and international architectural associations, along with the presidents of the U.S. collateral organizations (NCARB, NAAB, ACSA & AIAS), discussed current issues in the profession in a multilateral forum. All presidents were encouraged to submit updates on their national activities and any other documents they wished to share to supplement the discussion of the agenda topics. ### ACE Communication Workshop in Dublin



The focus of the Communication Workshop, held in Dublin on 15 June and attended by ten Members of the ACE Executive Board and Secretariat, was to review and streamline operational communications within ACE and with external partners. To ensure that resources are deployed in the most effective way, participants identified overall communication objectives congruent with ACE strategy. Then, a stakeholder analysis was carried out which led to a prioritisation of audiences. These findings provided a sound

foundation for the communications planning, which will be completed and enforced by the newly formed Communication Work Group in the coming months. The first meeting of the COM WG is scheduled early October.

### News of the ACE Work Groups

#### Professional Practice Experience (PPE+2)

In the context of the modernisation of the Professional Qualifications Directive, the ACE recently established a new Work Group to examine the question of Professional Practice Experience, which constitutes an essential complement to academic training. In its terms of reference, the WG has been tasked with establishing the current state of play in each European country and developing a policy and guidance for structuring the professional practice experience. The ultimate aim, in terms of mobility, is for a European citizen to be able to obtain a diploma in architecture in one country, traineeship in another country and practical experience in yet another. During the first meeting, which took place on 11 June, participants worked on the definition, the duration, the objectives and the conditions of the professional practice experience. The next meeting of the WG PPE+2 will take place in Brussels on 17 September.



### **Scope of services (SoS)**

This Work Group was established in 2010 to examine the scope of services generally offered by architects in each of the Member States of the European Union and draw conclusions from that information. To determine the current state of play in Europe, the WG launched a survey asking for detailed replies from Member Organisations. The answers have been analysed during summer and the summary will be presented at the ACE second General Assembly at the end of November 2012. In the coming months, the Scopes of Services WG will organise a joint meeting with Liability and Insurance WG in order to explore future steps towards developing a common core liability and insurance policy based on the scope of services survey results.

#### **CCA – Czech Chamber of Architects**

The Czech Chamber of Architects is now involved in the project CEC5 "Demonstration of Energy Efficiency and utilisation of Renewable Energy Sources through Public Buildings" with twelve other European partners. The aim of the project is to examine under what conditions it is possible in central Europe to have a unified certification tool for assessing the sustainability of building construction, particularly, in the public sector. CCA is responsible for Work Package Five. ACE Members and authorities will be informed of the project results.

#### **CNAPPC - National Council of Architects, Planners, Landscapers and Conservationists in Italy**

On 3 August 2012, the Council of Ministers approved the scheme for a Reform of the Liberal Professions in Italy. Important matters are affected by this Decree: compulsory insurance, compulsory internship (18 months), compulsory continual professional development, new regulation for advertising and ethical issues (introduction of a different disciplinary committee by the Council).

#### **CNOA – National Council of the Order of Architects in Belgium**



It is with regret that the ACE learned of the death of Mr. Georges Vranckx, a well-known Belgian architect, who was elected three times as the President of the National Council of the Order of Architects in Belgium and who participated in the creation of the Architects' Council of Europe. During his career, he received many awards. He was made Knight of the Order of the Crown and Officer of the Order of Leopold III, and he was also elected "Architect of the year" in 1984. ACE extends its sincere condolences to his friends and relatives.

#### **HKA – Croatian Chamber of Architects**

On 20 July 2012, the Croatian Chamber of Architects elected Mr Tomislav Curkovic as President for a three-year mandate.

#### **NAL – National Association of Norwegian Architects**

On the 1 of July 2012, the National Association of Norwegian Architects elected Kim Skaara as its new President.

#### **SARP – Association of Polish Architects**

## News about the ACE Involvement in EU-Funded Projects

The involvement of the ACE in EU funded projects allows it to engage with a wide range of stakeholders in the European Union and to advocate the role of architects in building sustainability and energy retrofitting. In October 2012 a new project called INSPIRE is kicking off and it will be the fifth project in which the ACE is involved. This project will be funded by the 7<sup>th</sup> Framework Programme and its' aim will be to conceive, develop and demonstrate systemic packages for deep energy renovation of buildings, both in the residential and tertiary sectors.

### OPEN HOUSE- FP7 Project



The objective of the [OPEN HOUSE](#) project is to develop and to implement a common European building assessment methodology for planning and constructing sustainable buildings. A prominent mention that OPEN HOUSE received in the recent Construction 2020 Communication from the European Commission is an important recognition of the work that has been performed in the first 30 months of the project's lifetime. Currently the developed methodology is being evaluated and refined through the assessment of 68 case studies (mainly office buildings from 35 countries). In the months to come, necessary adaptations will ensure that the methodology is suitable for all countries in Europe. ### LEEMA- FP7 Project



Among the objectives of the LEEMA project, is the development of a new generation of inorganic insulation materials and building-insulation masonry components. The developed materials will have significantly lower embodied energy (70-90%) and a lower unit cost (25-30% compared to the cost of commonly used insulation materials). Moreover, they will not be presenting any technical, health and/or environmental drawbacks. The LEEMA consortium comprises 14 partners, among whom 6 large industries related to building materials, 2 SMEs, 2 Universities and 2 Building Research Institutes as well as one large engineering company and the Architects' Council of Europe. One of the main roles of the ACE in LEEMA is to evaluate the new developed products in relation to the requirements of the end-users. ### The UK adopts Building Information Modelling (BIM)



The UK is looking to introduce Building Information Modelling (BIM) to support the new construction strategy set out by the Government in May 2012. In BIM the building is designed, built and operated with the help of an intelligent, virtual model, not just in 3D, but with all its associated cost, build-sequence and maintenance information. Moreover BIM addresses most of the issues set out in the recent paper from the EU Commission to Parliament and Council on “Strategy for the sustainable competitiveness of the construction sector and its enterprises”. Currently, the UK government is running several ‘early adopter’ projects to look at the effectiveness of the key innovations, including BIM. The

ambition is to use BIM throughout government by 2016 at ‘Level 2’ maturity, the stage of development most users could be expected to reach by then. For architecture, the use of BIM will represent a radical change, enabling better control of design and delivery.

## International Design Competition for Piazza d'Armi in L'Aquila



A little more than three years after the tragic earthquake that severely hit the city, the International Design Competition for a Public Park at Piazza d'Armi in L'Aquila (Italy) published its results. Strongly stimulated by the professional local community represented by the various territorial levels (the Order of Architects of the Province of L'Aquila and the Federation of Orders of Architects of Abruzzo and Molise), by the National Council of Architects and by Association of Citizens, the

competition was made possible thanks to the economic contributions of the National Council of Architects and some other partners. The winning project designed by Modostudio aims to create a thematic interaction between the competition area and the adjacent existing urban tissue. The architects accomplish this by means of creating a park for this city that is decontextualized from the neighbouring urban space and, at the same time, directly related to the skyline of the nearby mountains. The result of this competition is an example of a quality path for the reconstruction.
